

ORDINANCE NO. 1216

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF LAKE FOREST PARK, WASHINGTON, AMENDING THE 2019-2020 BUDGET ESTABLISHED BY ORDINANCE NO. 1184 AND SUBSEQUENTLY AMENDED BY VARIOUS ORDINANCES; AND PROVIDING SEVERABILITY AND ESTABLISHING AN EFFECTIVE DATE

WHEREAS, State law, Chapter 35A.34 RCW provides for the biennial adoption of the City's budget and provides procedures for filing of the proposed budget, deliberations, public hearings, and final fixing of the budget; and

WHEREAS, a budget for fiscal years 2019-2020 was adopted by Ordinance No. 1184 and subsequently amended by various ordinances; and

WHEREAS, the City of Lake Forest Park is required by Chapter 35A.34. RCW to review all revenues and expenditures for each fund in the adopted budget; and

WHEREAS, the Administration has proposed adjustments for several funds to better align the budget with current conditions in the originally adopted budget; and

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF LAKE FOREST PARK, WASHINGTON, DOES ORDAIN AS FOLLOWS:

Section 1. AMENDMENT. The 2019-2020 budget is hereby amended as follows:
