**YOUTH COURT AGREEMENT**

I agree to transfer this case from Lake Forest Park Municipal Court to the Shoreline/Lake Forest Park Youth Court. I understand by doing so I am agreeing to the following terms:

**TRAFFIC INFRACTIONS**

- 1 I admit to the commission of this infraction and do not seek a contested hearing on the facts
- 2 I have not had a prior traffic infraction referred to a “youth” or “teen” court.
- 3 I do not have a conviction for a violation of any provision of Title RCW 46 nor am I under the jurisdiction of any court for violation of any provision of Title RCW 46.
- 4 I will abide by the conditions set by the Shoreline/Lake Forest Park Youth Court and have no further traffic infractions for a period of 6 months from today’s transfer date, pending payment of the transfer fee. At the end of the probation period, the Youth Court will notify LFP Municipal Court of proof of compliance or non-compliance with Teen Court conditions. Upon successful completion of the conditions, the infraction will be dismissed.
- 5 I agree to pay the LFP Municipal Court \$30 in costs to transfer the case to Youth Court. If I fail to abide by the terms and conditions imposed by the Youth Court, the case will be returned to the LFP Municipal Court where a finding of “committed” will be entered and the full amount of the fine imposed. The fine must be paid within 30 days of the date set forth in the Youth Court Notice of Non-Compliance.
- 6 I understand that if, in the event I am required to pay the fine to LFP Municipal Court, failure to pay will result in notification by the Court to the Department of Licensing, which could result in the suspension of my license or privilege to drive until the fine is paid.

**I ACKNOWLEDGE THAT I HAVE READ THE ABOVE INFORMATION CONCERNING THE TRANSFER OF THIS CASE TO SHORELINE/LAKE FOREST PARK YOUTH COURT. I AGREE TO GIVE UP MY RIGHT TO A CONTESTED HEARING ON THE MATTER AND I AGREE TO GIVE UP MY RIGHT TO A MITIGATION HEARING WITHIN 120 DAYS FROM THE ISSUANCE OF THE TRAFFIC CITATION, AS SET FORTH BY COURT RULE.**

## IS YOUTH COURT RIGHT FOR ME?

- ▶▶ **Are you a student in high school?**
- ▶▶ **Are you 16 or 17 years old?**
- ▶▶ **Have you recently been charged with a traffic infraction?**
- ▶▶ **Would you like a way to have the charge dismissed and save the money you would spend on ticket costs or even higher auto insurance?**

If you answered yes to any of these questions, then the Shoreline/Lake Forest Park Youth Court may be the place for you!

The Shoreline/Lake Forest Park Youth Court is a place where you can go to be judged by your peers. You will explain the circumstances of the infraction and answer questions from your peers. The teen judge and jury will then decide on a sentence that they feel is fair. The sentence may include, but is not restricted to:

- ✓ Community service hours
- ✓ Writing letters of apology or essays
- ✓ Attending traffic school
- ✓ Attending a drug or alcohol counseling program
- ✓ Attending a DUI victim's panel

### **You may attend Youth Court if:**

- You have never had a traffic infraction referred to a youth or teen court
- You are 16 or 17 years of age
- You do not have a conviction for a violation of any provision of RCW Title 46
- You are not under the jurisdiction of any court for a violation of any provision of RCW Title 46

**Negligent Driving offenses will not be referred to Youth Court**  
**You may only attend the Youth Court if you admit to committing the offense**
