Each year the PW Department inspects, rates and refurbishes our thermoplastic traffic marking. This process is completed for 2021.



Each summer Public Works cleans sediment out of the McAleer Bypass and the 35<sup>th</sup> Brookside School Access Culvert. This is done under a Washington Department of Fish and Wildlife Hydraulic Project Approval (HPA). Above you will find pictures of the McAleer Bypass before cleaning, during and after cleaning.

This work reduces the risk of downstream winter flooding in the Beach and Shore Drive area, and was completed on 7/7 and 7/8/21.



### **Notable Incidents:**

A man called 911 stating his girlfriend was upstairs with a knife and he was worried about her hurting herself. Officers attempted to call her several times after it was discovered she had left the residence. Aid personnel treated the boyfriend for a cut he sustained while taking a knife from her. While officers were still on scene the girlfriend returned, still extremely upset. She admitted to choking herself with the intent to harm herself while they were arguing. Officers talked her into going to the hospital. Officers also provided her resources through our RADAR program.

Officer attempted to contact suspicious subject inside vehicle. Vehicle immediately fled,

striking one vehicle, and nearly striking the officer. Officer returned to his vehicle and attempted to stop the fleeing vehicle. Vehicle refused to stop, and the officer lost sight of it. The vehicle then crashed into the yard of a residence and the driver fled on foot. A K9 track was unsuccessful. It was discovered the vehicle had recently been stolen.

Officers responded to an No Contact Order violation. Subject reported his ex-girlfriend was stalking and harassing him. Suspect arrested for order violation. While in custody suspect made credible threats of suicide. Suspect sent to hospital for evaluation.

The police department is pleased to announce another police officer hire, Officer Brandon Carlsrud. Officer Carlsrud is a lateral police officer from the Brier police department. He was raised in Germany and is fluent in German. He will begin his training program in the next couple of weeks. Congrats!
